# **B.** Exclusive Chapter Policies & Procedures

## I. WRS Membership, Standards and Ethics

- 1. I am an approved member of WRS. I have attended or completed my Self-Study the "Networking in WRS" Seminar that is included with my WRS membership, completed my Membership Application and submitted 3 references to WRS.
- 2. I agree to maintain my status as a member in good standing by supporting WRS philosophy, upholding the ethical standards and following the policies, procedures and protocol.
- 3. I understand that by applying for assignment to this Chapter I am asking WRS Members to extend loyalty to me in the form of referrals and I am willing to make this same commitment even though I am aware that there are no fines or requirements to do so. I also agree to have a fellow WRS member satisfy my personal or business needs whenever possible. My first loyalty is to members of my Exclusive Chapter and secondly to WRS Traditional Chapter members.
- 4. I agree to dress and act in a professional manner at all times.
- 5. I agree to report any breach of Ethics to WRS (to subsequently be passed to the WRS Anonymous Ethics Committee, if they feel the situation warrants action).
- 6. I agree to support, respect, and honor the diversity of all members and their types of businesses.
- 7. I agree that, if I have a concern about a member whose categories may conflict with mine or any other conflict or issue with a member, I will contact WRS Central immediately and I agree NOT to approach members directly to address my conflict or issue during a WRS Exclusive Chapter meeting.

#### II. Assignment to WRS Exclusive Chapter

- 1. I understand that members are assigned to Chapters on a first come, first served basis.
- 2. I understand that I will ONLY be assigned to an Exclusive Chapter once I am an Approved Member of WRS.
- 3. I understand that final approval of my assignment to this Chapter rests with the WRS Anonymous Committee.
- 4. I understand that, at this Exclusive Chapter, I may only represent, sell, or talk about products and/or services that match the exact specifications of my approved category assignment for this Chapter.
- 5. I understand that to change my business or category I must first have the approval of the WRS Anonymous Assignment Committee.
- 6. I agree that my assignment to the Chapter may be terminated if deemed so by the WRS Anonymous Committee.
- 7. I understand that the Members of this Chapter may choose to forfeit my assignment position in this Chapter by a 2/3 vote for any reason they deem necessary.
- 8. I understand that I may submit other WRS members and/or categories to be considered for inclusion in my Chapter to the WRS Central Office.

## III. Leadership

- 1. I understand that members are given the opportunity to be an Exclusive Chapter Facilitator, Assistant Facilitator or Hospitality Chair on a rotating basis based on seniority (based on the date they were assigned to the Chapter).
- 2. I understand that, in order to be a Chapter Leader, I must either attend the Exclusive Chapter Leadership Certification Training or complete the Self-Study.
- 3. I understand that I will be notified 3 months in advance when it is my turn to Facilitate the Chapter.

#### **VI. Meeting Practices and Procedures**

- 1. I understand that it is important to be present for the full meeting, therefore if I arrive late or leave early it counts as one missed meeting.
- 2. I understand that my assignment in a WRS Exclusive Chapter is non-transferable even for only one meeting. No one may attend the meeting in my place.
- 3. I understand that Exclusive Chapters meet only one time per month. To insure the success of the Chapter, it is imperative that members attend on a regular basis. Therefore, if I miss more than two meetings in a 12-month period, my assignment to this Chapter may be subject to a vote by the Chapter.
- 4. I understand and agree that my assignment to this Chapter may be forfeited because of lack of attendance; however, I may continue to network at any WRS Traditional Chapter meeting or Mixer.
- 5. I understand that I may only attend other WRS Exclusive Chapters only if I am assigned to the Chapter; however, I may attend any WRS Traditional Chapter meetings and Mixers as often as I wish.

## V. Visitors & Automatic Assignments

- 1. I agree to invite visitors to this Chapter if there is a vacancy in his/her category.
- 2. I understand that I may invite non-members of WRS to attend my Exclusive Chapter meeting only if their category is vacant.
- 3. I understand that I may invite approved members of WRS to attend my Exclusive Chapter meeting one time but only if the category they represent is vacant.
- 4. I understand that if I bring a visitor to an Exclusive Chapter meeting, they must call the Central Office to prepay.
- 5. I understand that no one, visitor or WRS member, may walk in to my Exclusive Chapter meeting without a reservation or approval from the Central office.
- 6. I understand that, if I attend this meeting as a visitor first, I must submit this agreement to the WRS Central Office. I understand that, I will be automatically assigned to the Chapter 48 hours after I attend the meeting unless I notify WRS in writing.

#### VI. Payment

- 1. I understand that, by signing where indicated on page 2 of this agreement, I authorize WRS Central to charge my credit card for the Exclusive Chapter meetings beginning with my date of assignment.
- 2. I agree that my credit card will be charged every 3 months for the next 3 consecutive meetings of the WRS Exclusive Chapter to which I am assigned.
- 3. I understand that I am paying for all meetings in a 3-month period and may not receive a refund or transfer for any meetings I miss. FYI, there are no "Rollovers" for Exclusive Chapters because WRS has to pay whether you attend or not.
- 4. I understand that I will automatically be charged for the next 3 consecutive meetings the next business day immediately following my last prepaid meeting for this Chapter.

#### VII. Withdrawal from the Chapter

- 1. I agree to provide written notice to WRS, if I should choose to withdraw from participation in any Exclusive Chapter.
- 2. I understand that the WRS Central office <u>must receive</u> my written notice 30 days prior to the date I wish to withdraw from the chapter.
- 3. I understand that when I withdraw from my Exclusive Chapter, any unused portion of my prepaid reservation may be put in my WRS MIP account to be used for other WRS services or Traditional Chapter meetings and WRS Mixers. The "unused portion of my prepaid reservation" is equal to the number of unused meeting reservations that occur AFTER my 30 days notice.
